3. Non marking tennis shoes only.
4. Courts open 7am-dark
5. Do not hang or lean on the nets or attempt to jump over them. The nets and nets straps will be damaged.
6. Tennis ball cans, tops and other debris should be placed in the trash cans upon exiting.

Windsor Forest Pool Rules

The following rules and regulations are for the protection and benefit of all members and their guests. The rules have been established to assure an enjoyable, safe, and sanitary pool operation.

Pool sign in procedure: There is a member list where all currently members are listed. Please put a check besides your name when you enter pool. If you are not on the list see the guard or pool manager. (NO Exceptions)

GUESTS:

No one residing within the boundaries of Windsor Forest will be permitted as a guest.. Pool members must accompany all guests. As many as five bona fide house guests, i.e. those guests actually residing in a member's home for up to two weeks and who live at least thirty miles from Windsor Forest, will be allowed to use the pool facilities free of charge. After two weeks, house guests will be asked to pay appropriate daily guest fees.

DAILY guest fees are \$2.00 for guests living within 30 miles of pool. . Fees are payable upon sign-in. Guests will abide by the rules and regulations of the Windsor Forest swimming pool and the sponsoring member is responsible for their conduct. Family members not residing in the house are considered guests.

RULES OF CONDUCT, HEALTH AND SAFETY:

THE FOLLOWING ARE NOT BE PERMITTED IN THE POOL AREA:

- 1) Animals
- 2) Glass containers
- 3) Skateboards or other recreational equipment not related to swimming, Except that equipment owned by the pool
- 4) Chewing gum
- 5) Personal radios or phonographs except the one under control of the manager
- 6) Tennis or any other type of ball, or rafts
- 7) Intoxication
- 8) Spitting, spouting, nose blowing, etc., in the water
- 9) Running, wrestling, dunking, horseplay, etc.
- 10) Interference with lifeguards on duty. Members and guests are not permitted to carry on conversations with the lifeguards on duty. Loitering around lifeguard chairs is not permitted.
- 11) Jumping, hanging, or pulling on dividing ropes
- 12) Any other conduct which, in the manager's opinion, may be detrimental to an enjoyable, safe, and sanitary pool operation.

RULES FOR THE USE OF THE POOL:

- .. Only approved swimming attire will be permitted. Glasses, face masks, and other equipment must be approved by the manager or a lifeguard.
- .. Flotation devices are not a safe substitute for close parental supervision. Hence, such devices are only permitted in the two-toot, roped off area, when a responsible person is watching the child, and the device is approved by the pool manager or assistant manager.
- .. Only one person shall be permitted on the diving board at any one time. Diving shall be done from the ends of the board and not from the sides of the board. Persons using the board should, preparatory to diving, determine that the area is free of swimmers. Intentionally diving or jumping close to someone in the water is prohibited. One bounce on the diving board is permitted.
- .. Persons with skin diseases, open lesions, bad colds, inflamed eyes, nasal or ear discharges, or communicable diseases will not be allowed to use the pool. Persons wearing tape or bandages will not be al-

lowed to use the pool.

All members are expected to keep the pool area clean of trash and debris. Waste containers are available for this purpose. All members are also asked to help keep the restrooms clean.

DISCIPLINE ACTION:

The manager and/or the lifeguards on duty may restrict anyone from the use of the pool or pool area for the balance of the day if, in their opinion, the individual’s presence is detrimental to good order, health, safety or discipline. Repeat offenders will be reported to the pool committee for appropriate action.

FINANCIAL LIABILITY FOR DAMAGE OR LOSS OF PROPERTY OR PERSONAL INJURY:

Damage to property caused by members and guests will be charged directly to the member concerned.

All persons using the pool do so at their own risk. The Association or any member will not be responsible for accident or injury connected with such use.

The Association will not be responsible for any loss of money or other property by members or their guests.

PARKING

Please park cars on the pavement or in the overflow parking in the field .Do not block the field entrance to overflow parking. If it is necessary to park down the road, or on Buford Road, please do not block residents’ driveways. All bicycles are to be parked in the designated bike area. There will be no parking signs installed on the north side of Wyndham Way so parking will only be permitted on the right side of Wyndham when leaving the pool.
